Mission:

Support poverty reduction and sustainable development actively engaging the NGOs in the process of collaboration with each other, as well as with Governments, intergovernmental structures, international organizations and all interested institutions.

Goal:

Consolidate efforts of NGOs and collaborate with each other for the overall development of social partnership, support for the solution of social issues, as well as for the elaboration and execution of efficient and effective social policy in the region.

Strategic Issues:

- To strengthen NGOs' cooperation at a regional level, to promote strengthening of Civil Society Institutions in the region.
- To lobby regional intergovernmental organizations (primarily Organization of the Black Sea Economic Cooperation (BSEC) and Parliamentary Assembly of the Black Sea Economic Cooperation (PABSEC)).
- To promote social policy improvement at regional, national and LSG levels through cooperation with relevant governmental institutions and implementation of lobbying and advocacy within their scopes.
- To address the needs of vulnerable groups through elaboration and implementation of joint programs.

Achievements:

- Creation of Advocacy Manual for NGOs in Black Sea region (2008) entitled: "Advocacy in International Institutions by Civil Society Organizations. A Practical Guide".

The Manual describes and analyses 5 international institutions: BSEC, PABSEC, EU, WHO and UNDP. In the manual you will find the structure, activities of these organizations, their experience of interaction with Civil Society Organizations, the possibilities and mechanisms and how to lobby and advocate to these organizations.

- Within the Union framework create working groups to make its activities in specific areas more effective.
